In relation to our customers, suppliers and other business partners we are handling the following personal data:

- Contact information:

Name, company phone No., company e-mail address

The legal basis for handling your personal data is as follows:

- Contact information is used to run the daily business with our customers, suppliers and business partners.
- For instance sending out offers, supplying goods, sending out invoices, giving information about deliveries or delays. Ordering transport and delivery.
- In connection with reservation of air tickets and hotels in connection with customers visiting us.
- For instance in connection with inquiries about our services, received invoices, remittance and claims.

Personal contact information originates from:

- Personal contact information from contact to or from customers, suppliers and business partners and from their homepages.
- We can receive contact information from external company references as well.

Disclosure of contact person information can happen to the following:

- Other sub-suppliers – for generating quotations *as well as passing over orders and for customer visits to our production sites.*
- Freight and shipping companies – *for supplying and handling customer clearance of goods.*
- The auditing firm BDO – *for auditing our accounts.*

Keeping of contact person information:

- We keep your contact person information as long as we need these for conducting business with your company.
- We are at present not able to inform you for how long we will keep your contact person information after that we have concluded our business relation with your company. However we can inform you that we emphasizes if it is of relevance to keep your information in relation to future updates on the product you have bought when we decide how long to keep the information.

If you apply for a job with us, the following personal information is processed:

- Name, address, phone number, e-mail address as well as other information from the applications
- We receive information from applications sent to us.
- We need this information to be able to occupy the vacancy.

Keeping your personal data:

- We keep your personal information for maximum 6 months.
- Should it be necessary to keep your applications for longer than that we will ask for your consent.

You have a number of rights under the General Data Protection Regulation in relation to our processing of information about you. If you want to use your rights, please contact us.

Right to see information (right of access) and correction

You are entitled to gain insight into the information that we are processing about you, as well as a number of additional information. You are entitled to have incorrect information about yourself corrected.

Right to have information deleted

In special cases, you have the right to get information about you deleted before the time our general deletion occurs.

Right to limitation of data handling

In certain cases, you have the right to limit our handling of your data. If you have the right to such a limit we in the future – apart from keeping – are only allowed to handle your data with your consent,

Right to protest

In some cases, you may object to our otherwise legitimate processing of your personal information. You can also object to our processing of your information for direct marketing purpose.

Right to transmit information (data portability)

You may, in certain cases, have the right to receive your personal information in a structured, commonly used and machine-readable format and to have such personal data transferred from one data manager to another without any hindrance.
